



HOBBY FARMERS TERMS AND CONDITIONS

1. SELLING FEES
 - a. Vendors
 - i. 5% + GST on cattle and sheep.
 - ii. 10% + GST on all other lots.
 - b. Buyers
 - i. 5% + GST buyers premium (cattle and sheep exempt).
 - c. Yard Dues
 - i. Yard dues will be payable on sheep and cattle.
 - d. Advertising
 - i. An advertising levy of 1% on the sale price will be charged to all vendors.
2. ONLINE PURCHASES
 - a. If you are the successful bidder McCulloch Agencies will send the invoice to you within 24 hours of the sale.
 - b. You then have 5 days to make full payment of that invoice.
 - c. Once you have paid for the item a member of McCulloch Agencies will contact you to advise the location of the item and organise a time for the pick-up of the goods.
 - d. Goods will not be allowed to be picked up until full payment has been received.
 - e. Purchases have 4 days from the date of issue to pay for the pick up of goods.
3. ADDITIONAL TERMS & CONDITIONS
 - a. All sales will operate under the ALPA Selling Terms and Conditions ([View Here](#)).
 - b. All sales will operate in conjunction with TRLX and under their terms and conditions ([View Here](#)).
4. ANIMALS
 - a. No one is allowed in pens with any animals whilst they are on the TRLX premises other than the animals' owner.
 - b. Any item of tack or equipment on or housing livestock must be identified as "for sale" or "not for sale".
 - c. Any livestock needing to be fed and watered overnight must be organised with McCulloch Agencies at the fall of the hammer.
 - d. McCulloch Agencies will be assessing all livestock on the Fit To Load Guidelines ([View Here](#)).
 - e. Livestock
 - i. For all sheep, cattle and goats, vendors and buyers must supply a PIC number and NVD (National Vendor Declaration).
 - ii. If you do not have a PIC number please call Local Land Services 1300 795 299 or [visit here](#).
 - iii. No National Vendor Declaration (NVD) no sale.
 - f. Pigs
 - i. All pigs must have a Pig Pass and appropriate identifiers ([View Here](#)).
 - ii. All smaller pigs must be caged.
 - g. Dogs

- i. No pups under 16 weeks old are to be sold or auctioned.
 - ii. Dogs must be in healthy condition.
 - iii. Dogs must have current vet vaccination certificates.
 - iv. The responsibility for the wellbeing, control and restraint of the dogs and their actions rests with the owner.
 - v. All dogs must be muzzled and kept on a leash at all times. No muzzle no entry.
- h. Birds
 - i. All birds must be caged.
- i. Horses
 - i. No branded Thoroughbred horses will be accepted for sale.
 - ii. Only owners are allowed to handle horses.
 - iii. Only owners are allowed to ride horses.
 - iv. Any owner riding a horse must wear a helmet.
 - v. All horses must be accompanied by a Transport Stock Statement ([View Here](#)).
- j. Animal Welfare
 - i. All livestock offered for sale must be transported and cared for following the relevant animal welfare guidelines ([View Here](#)).
 - ii. Caged Birds ([View Here](#)).

5. PAYMENT TERMS

- a. McCulloch Agencies will not make cash payments to vendors. All vendors must supply bank account details for payment.
- b. All goods purchased must be paid for on the day or goods will not be allowed to leave the venue.
- c. Cheque or Eftpos will be accepted.
- d. Payment for buyers on sale day or no delivery of goods.
- e. Payment to vendors is required within 7 working days.
- f. GST
 - i. This is a multi-vendor sale. Not all vendors will be registered for GST.
 - ii. Buyers should assume that GST will be added to the final knock-down price on all lots.
 - iii. Buyers can book back through an agent if they hold a letter of introduction.

6. MISCELLANEOUS

- a. Sales will operate using a bid card system.
- b. All goods must be removed from TRLX by 4:00pm on sale day.
- c. A \$35.00 per lot removal fee will be charged to vendor buyers for all lots left on the premises.
- d. Sale bookings will close 5:00pm on Thursday before the sale.
- e. Curfew by 8:00pm Friday for sheep and cattle only.
- f. All other lots for sale will not be accepted before 6.00am on the day of the sale.
- g. McCulloch Agencies take all care of your goods and livestock but have no responsibility.
- h. Responsibility for all lots will lie with the purchaser at the fall of the hammer.

7. PROHIBITED ITEMS

- a. Any type of chemical or fuel (opened or unopened).
- b. Any reptiles.
- c. Any wild animals such as feral pigs, dingoes and native birds.
- d. Motor vehicles.
- e. Thoroughbred racehorses.
- f. Pig dogs, at McCulloch Agencies discretion.
- g. Any type of weapon, fake or real.
- h. Alcohol, drugs and medicines.
- i. Any animal that is not fit for sale.
